POLICY & ADVOCACY

Progress on Sugar Research Australia's independent review & new CEO

Throughout July, ASMC has engaged with Sugar Research Australia (SRA) to ensure their response to the independent review of sugar R&D provides positive outcomes for the milling sector. The ASMC has been seeking greater transparency of SRA resourcing of R&D, better industry engagement on resourcing and research priorities and constitutional reform to ensure a more receptive and agile SRA.

The SRA will provide a formal response to the review in August and has also sought direct feedback from mills on their response.

New SRA CEO

In July, the SRA announced Mr Mick Bartlett as the new CEO of the SRA. Mr Bartlett will commence his role on 14 October 2024. The ASMC and members welcome the announcement and look forward to working with Mr Bartlett on the R&D needs of the sector and industry.

New Federal Minister for Agriculture, Fisheries and Forestry.

On 27 July 2024, the Honourable Julie Collins MP was announced as the new Federal Minister for Agriculture, Fisheries and Forestry. Minister Collins was previously Minister for Housing and was the Shadow Minister for Agriculture in opposition.

Senator Anthony Chisholm, a Queensland Senator, has been appointed the Assistant Minister for Agriculture.

The ASMC welcomes Minister Collins to this important role and looks forward to working with her to advance the progress of the sugar industry.

Renewables meets Queensland Parliament engagement continues

The ASMC has teamed up with Bioenergy Australia, fuels suppliers, aviation and maritime industry representatives (amongst others) to meet with Queensland parliamentarians to highlight the opportunities and challenges for Queensland in biofuels. Meetings held in July have included the Honourable Craig Crawford MP, and Nick Dametto MP.

The ASMC highlighted the strong role the sector can play in biofuels with the right government incentives. Meetings will continue through to the end of August.

ASMC meeting with the new Director General for the Department of Agriculture, Fisheries and Forestry

The ASMC met with the new Director General of the Department of Agriculture, Fisheries and Forestry, Mr Graeme Bolton, to discuss the priorities of the milling sector and to establish a regular ASMC / DAFF forum to ensure progress on common priorities.

Federal Government consultations on transport and infrastructure sector decarbonisation

The ASMC highlighted in its submission to the Federal Government, that biofuels will be the primary (or substantial) medium-term decarbonisation pathway, for many hard-to-abate emissions from the transport sector. The ASMC analysis suggests sugar manufacturers can provide up to 10% of the domestic demand for sustainable aviation fuel (SAF). The advantage of sugar derived biofuels (e.g. those reliant on ethanol) is that its production has been proven commercially.

Consultations on the Federal Government's 'Future Made in Australia' initiative

In its submission to the Made in Australia Low Carbon Liquid Fuels consultation, the ASMC has highlighted the need for a national feedstock strategy if Australia is genuine about developing a domestic capability in biofuels. Any demand or supply-side incentives must create an environment where feedstock, such as bagasse, molasses and cane juice, can be viably supplied for processing, noting alternate economic uses for the feedstock. Bioenergy Australia Low Carbon Liquid Fuel Workshop

To promote the opportunities and challenges for the sugar industry within the biofuels supply chain, the ASMC also participated in the Bioenergy Australia Low Carbon Liquid Forum that included Federal Government, fuel producers and end user participants.

The ASMC highlighted the need for a national biofuels feedstock strategy that ensured land-use planning, freight infrastructure decisions and environmental regulations allowing for the optimal supply of feedstock (such as sugar), for food, fuel and fibre.

The ASMC also sought mechanisms to incentivise supply and long-term offtake agreements, including consideration of a potential Renewable Energy Target framework for biofuels.

QCAR Sugar Industry Forum - An industry forum without the industry

The ASMC has highlighted its disappointment at the Queensland Cane and Agriculture (QCAR) 'industry' forum, that purported to take an industry approach to the challenges facing the sugar industry. There was not a genuine attempt to seek industry participation in the forum outside of those close to the QCAR agenda.

The ASMC has noted that the sugar industry works in a challenging environment whether in the growing, contract harvesting or milling sectors, however, there are so many opportunities available to our industry and 2024 will be a positive year with the crush forecast to be 31 million tonnes, up 1 million tonnes from 2023 and global prices above break-even point.
