## POLICY & ADVOCACY

### New R&D investments by Sugar Research Australia

On 2 December 2024, Sugar Research Australia and the Queensland Department of Primary Industries announced \$32.6 million of new R&D projects, including \$5.5 million towards R&D aimed at optimising mill operations and deliverying enhanced milling efficiency. This is a welcome first step in refocusing the sugar industry R&D agenda towards those issues that will progress both the growing and milling sectors.

On 15 November 2024, representatives from across the milling sector, including the ASMC, and the SRA held a workshop to explore opportunities in setting up an 'Advanced Sugar Manufacturing Centre of Excellence'. The stated aim of this exercise was to focus on R&D for sugar manufacturing, with a greater emphasis on technology transfer, development and commercialisation.

A white paper is being developed by the SRA for the milling sector to provide feedback on the viability and efficacy of the proposal.

## Results of resolutions from Sugar Terminals Limited AGM announced

The results from the Sugar Terminals Limited (STL) Annual General Meeting (AGM) held on 20 November 2024 was delayed due to the requested involvement of scrutineers for the counting of the polls and validation of proxies associated with the various resolutions.

On 6 December 2024, STL announced the results of resolutions passed at its AGM. Results include:

- Paul Schembri was elected as a Grower Director.
- The selection of a new Independent Director was still in progress and yet to be announced.
- STL received a second strike against the adoption of its Remuneration Report, however, the Conditional Spill Resolution was not passed. The increase to the Maximum Aggregate Limit for the Directors' Remuneration Pool was passed.

At the AGM, STL noted their commitment to continue on the pathway of insourcing operations, with transition arrangements to be progressed to assume full responsibility for terminal operations from 1 July 2026.

# Indian Sugar & Bio-Energy Manufacturers Association suggests the need to export

On 26 November 2024, the Indian Sugar & Bio-Energy Manufacturers Association (ISMA) provided a presentation to the International Sugar Organisation Conference that suggested, amongst other things, the Indian Government had been requested to allow exports of two million tonnes of sugar, noting that it had currently ruled out quotas for sugar exports from India.

The unexpected entry of such quantities of sugar supply would be highly disruptive to global sugar markets, and the ASMC has reached out to the Australian Government and is reaching out to ISMA to get a more detailed understanding of developments.
